## YOUR QUESTIONS ANSWERED

### WHAT IS THE TAX RULE?

VAT Notice 708/6 was introduced by the government to support the reduction of carbon emissions by encouraging the installation of energy saving heating components through a reduced VAT rate of 5%.

### HOW DOES IT WORK?

CORGI VAT Saver works on an extremely complicated algorithm that allows you to calculate your VAT taking into account the 'energy saving' element of the job being subject to the lower VAT rate.

All you do is enter the details..... easy!

### HAS IT BEEN APPROVED?

# INSTANT ACCESS TO SAVINGS

### WHEN CAN I USE CORGI VAT SAVER?

Whenever your customer is NOT reclaiming VAT, you can use CORGI VAT Saver. It may be possible to use CORGI VAT Saver for domestic installations for Housing Associations, as well as for charitable organisations, but we recommend that you contact us for guidance in these circumstances. You cannot use CORGI VAT Saver for grant funded installations.

### HOW MUCH VAT CAN I SAVE?

Each installation is different, but for example:  
Domestic Installation

- Cost to consumer: £2,350 (inc VAT )
- Without CORGI VAT Saver, VAT at standard rate is £350.00
- Using CORGI VAT Saver, total VAT is about £240.00
- Overall VAT saving of £110.00\* for every boiler installed.

### HOW MUCH WILL IT COST ME?

There are absolutely no up-front charges and no monthly fee, you only pay when you save! CORGI VAT Saver will only charge 33% of what you save between VAT calculated at the standard rate and at the reduced rate applicable to energy saving materials (approx: £35.00 on average), giving you a net saving of £75.00\*\* for every boiler installation.
